Accordingly the financial results for the quarter ended September 30, 2017 have been prepared in accordance with Ind AS and other accounting principles generally accepted in India and the results for the comparative quarter ended September 30, 2016 have been restated in accordance with Ind AS. The financial results for the quarter ended September 30, 2016 have not been reviewed or audited by the auditors and are compiled by the management after exercising necessary due diligence to ensure that these give a true and fair view of the Company's affairs.
4. Reconciliation of results between previous reported (referred to previous GAAP) and Ind AS is presented as below:


